#### **DIRECTOR'S REPORT**

Presentation by staff to board ensued.

Factors that affect health-changing behavior is one of the key things we do such as masking. It is more complicated than going to a doctor and getting a pill. The number of COVID cases is going down. The governor's office sets the priority populations and the timeline on who is to receive the vaccine. In our chart we have no longer symptomatic instead of recovered because there have been some lasting symptoms for many individuals. We will not know the extent until later. 2.94% of the TRPHD area has been vaccinated so far. Majority of vaccines have gone to partners in the districts to vaccinate priority populations. Vaccines: Pfizer and Moderna are said to be highly effective and additional vaccines are waiting for FDA approval.
