

## Weekly COVID-19 Risk Update

KEARNEY – Two Rivers Public Health updated the weekly risk dial on Thursday, November 4, 2021. The risk dial remains in the red "Pandemic" level of risk.



Risk Dial for COVID-19 Two Rivers Public Health Published Nov 4, 2021

- 420 cases of COVID-19 were recorded in TRPHD between October 27- November 2, of which 31 were at longterm care and other residential facilities. 1 out of every 8 tests (including routine testing) conducted in TRPHD in the past week was positive.
- In the past week, Phelps County recorded 72 cases, over 10% of all tests returned positive. Meanwhile, Dawson County recorded 122 cases. Over half of all new cases in Phelps were aged less than 40 years while a similar proportion in Dawson were aged 40-70 years of age.
- Only 1 out of 29 ICU beds across TRPHD are currently available. COVID patients account for over 20% of all medical and surgical beds across TRPHD. About a third of medical/ surgical beds are currently available.
- A testing site at the Buffalo County fairgrounds (drive-through testing with prior online registration, Mon & Wed, 9:30-12:30) is now operational. People availing this service are required to register prior to testing at <a href="http://www.trphd.org">www.trphd.org</a>.
- As of Nov 2, 2021, 47% of TRPHD's total population and 58% of the adult population (18+ years) has received the minimum recommended dose of vaccine (2 doses for Pfizer & Moderna; 1 dose for Janssen). Over 6000 persons across TRPHD have received a booster or extra dose of vaccine. - The risk dial remains unchanged from the previous week within the 'pandemic' zone. The risk assessment reflects dramatically higher case rates, ICU bed availability, COVID hospitalization rates and the rapid spread of new cases in specific clusters across the district.
